MINUTE OF THE TAM SELANGOR BRANCH 78th ANNUAL GENERAL MEETING

REGISTRATION OF MEMBERS

The registration of members began at 9:30 AM. A total of thirty-three (33) Selangor members were present, as listed in Appendix A.

1.0 WELCOME ADDRESS by CHAIRMAN of TAM SELANGOR BRANCH

The meeting was called to order at 10:00 AM by Ts. Eng Poh Teik, the Chairman for the session 2024/2025. Ts. Eng Poh Teik warmly welcomed, Dr. Md Fauzi Md Ismail MBOT Registrar, Ts. Ir. Choo Kok Beng, TAM Past President, Dato Ir. Fong Tian Yong, TAM Past President, Ts. Ir. Yam Teong Sian, TAM Immediate Past President, Ts. Tung Chee Kuan, TAM President, senior members and all attending members for their presence.

The Honorary Secretary for session 2024/2025, Ms. Tiang Kor Lin, confirmed that the meeting had met the quorum of more than thirty-three (33) Selangor members and was valid to proceed.

2.0 TALK BY Ts. Dr. LAW FOONG LI

Emcee Ts. Joel Lim Soon Yeen, welcomed the speaker, Ts. Dr Law Foong Li to deliver a talk on '**AI in Malaysia: Present & Future**'

Ts. Dr. Law highlights the growing importance of AI solutions and its wide range of applications, especially in industries like hospitality, healthcare, and finance. They discuss the evolution of AI from traditional expert systems, introduced in the 1950s, to modern AI that mimics human behavior and enhances problem-solving. The focus is on how AI technology, including machine learning and natural language processing, has revolutionized tasks such as inventory management, customer service, and even video game creation. The application of AI is seen as not only improving efficiency but also reducing the need for human intervention in certain areas, such as hospitality, where AI-powered assistants can replace traditional roles. The speaker also touches on the importance of data in creating accurate AI models and the need for continuous learning and ethical considerations in AI development.

In addition to discussing the technical aspects of AI, Ts. Dr Law emphasizes the numerous career opportunities emerging in the field, such as machine learning engineers, data scientists, and computer vision engineers. They explain how AI's ability to understand and interpret data, such as through natural language processing, is key to advancing human-machine interactions. While AI solutions offer promising benefits, there is an acknowledgment that the technology is still evolving, with challenges like model accuracy and the need for human oversight in decision-making processes. The talk concludes

with a discussion on the future of AI, highlighting the balance between automation and human collaboration, as well as the importance of adapting to new AI tools to stay competitive.

The session concluded with an active Q&A session during which participants engaged with Ts. Dr. Law Foong Li.

- He referred to M&A Rule 38, which states: "accidental omission to give any such notice to any of the members shall not invalidate any resolution passed at any such meeting or any election of officers or other act which would have been valid if such notice has been duly given".
- The Chairman further assured that the Committee will be more mindful in future to ensure compliance with the M&A requirements.

9.2 One member raised a query regarding the annual report, noting that certain activities appeared to be organized by the Branch, although not all were solely organized by it.

- Chairman Ts. Eng Poh Teik clarified that the annual report was intended to list activities in which the Branch was involved, and at no point did the Branch claim sole organization of those activities.
- To address the concern, the Chairman reviewed the annual report during the AGM in the presence of members, demonstrating that the report did not state the activities were organized solely by the Branch.
- He further assured that future annual reports will provide clearer details on the Branch's level and type of involvement in each activity.
